9.30-11.00: Prospects and Challenges of the European Project (Plenary hall) 2015 has been a difficult year for the European Union. The refugee crisis poisoned relations among various EU member state governments, stirring up doubts about the Schengen area and free movement of people within the EU. Anti-EU populism is on the rise across the continent; political forces that feed on it are becoming mainstream. In addition to that, the prospect of the Brexit in 2016 will also increase strains at the political foundation of the Union. Optimists, however, urge European leaders to recognize that every crisis also presents an opportunity to rejuvenate the European project. Be as it may, there are more legitimate reasons than ever to ask the big questions about Europe's future prospects.
