The objective of this round table is to predict future scenarios. Cohesion policy has proven that it can address multiple challenges at regional and local level: Demographic change, environmental challenges relating in particular to climate change, new migratory flow patterns, the "fourth industrial revolution", new challenges in the field of energy and other drivers that will shape new scenarios. The future Cohesion policy will be adopted by a different EU, with a new form of economic governance, an evolved Economic and Monetary Union, an increasing territorial divide and probably different intergovernmental approaches.

2 p.m. Round table 2: Cohesion policy of the future – what should its focus be?

The aim of this round table is to define the variables that will shape the future Cohesion policy, according to the focus that it adopts. Cohesion policy could vary according to its goals: It may consist of addressing territorial, social and economic imbalances, it can focus on macroeconomic convergence, or it can prioritise investments. Cohesion policy may also adopt different forms depending on how the place-based approach is understood: national, regional and local level implementation; which priority is given to the urban agenda, the role of urban-rural integration and the future of rural development, are also items to be discussed.
