FOREWORD



2013 proved to be an especially intense year both for the European Union and for our think-tank.

The financial, economic and social crisis that has struck the EU continued to have a negative impact on most of the member states. While the crisis did not affect euro area's solidity, it nevertheless continued to trigger a great deal of debate and tension, particularly with regard to the correct balance between austerity and growth and to the welcome implementation of the banking union. 1. OUR ACTIVITIES

In 2013 the NE-JDI produced analyses and recommendations primarily in the shape of publications and events, the content of which can be consulted on our website: www.notre-europe.eu

In 2013 the NE-JDI disseminated 106 publications (see www.notre-europe.eu, Heading "Publications"): 33 Tribunes, 45 Policy Papers, 9 Studies & Reports and 19 Syntheses.

The NE-JDI also hosted or co-hosted 47 events (conferences, debates, presentations with debate and select smaller-scale seminars) in 8 countries: Belgium, France, Germany, Italy, Luxembourg, Spain, the United Kingdom and the United States of America. The presidents and members of the NE-JID team were also regularly in demand to air their expert views at conferences hosted by other institutions and organisations, taking part in over 110 events in 21 countries both inside and outside the EU (see www.notre-europe.eu, Heading "Events").

In 2013, the NE-JDI regularly intervened in the European and international media, allowing us to add value to our work and to adopt a stance in the most important current debates. All in all, over 220 appearances by the presidents, governing bodies, director and team of NE-JDI were recorded in the various media in France, in the EU countries and beyond (see www.notre-europe.eu, Heading "Medias").

Our work developed along three major axes: "European Union and citizens", "Competition, cooperation and solidarity," and "European external actions", generating the main activities illustrated in greater detail below.

Our work will continue throughout 2014 in the endeavour to remain in tune with the European decision-making agenda and with ongoing and emerging political debates, reflecting the working programme approved by our Board of Directors (see www.notre-europe.eu, Heading "Themes of our work").

1.1. Deepening European Political Union

1.1.1. Political Union and Federation of Nation States

The fresh boost imparted to the debate on "political union" prompted us to pursue our project bearing on the shape which this union has, at this juncture, already acquired, namely that of a Federation of Nation States, to use the expression coined by Jacques Delors.

This project consisted in an analysis of the links established between certain member states and the EU (Cyprus, Estonia, Germany, Ireland, Latvia, Lithuania and the United Kingdom). It also addressed the development of the division of competences between the EU and its member states in the context of the reform of the governance of the EMU. It also prompted us to publish a study on the national anthems and flags of the EU's member countries (and those of the EU itself) in an effort to explain their origin and significance so as to foster increased mutual familiarity and understanding among Europe's citizens.

1.1.2. European Institutions

The NE-JDI was eager to deepen its work on the European institutions, focusing primarily on the European Council, which has become an increasingly central player in the European political game thanks to the crisis and to the Treaty of Lisbon. The project consisted, for example, in interviews with António Vitorino, who discusses the issues on the agenda of each European Council meeting.

The development of the governance of the EMU also produced analyses and recommendations, focusing in particular on the role that the European and national parliaments can play in this connection (with, in particular, the drafting of a report ordered by the European Parliament in conjunction with TEPSA).

And finally, the development of the European institutions and of the European construction process led to the adoption of comprehensive positions, also by our founding president Jacques Delors and our honorary president Pascal Lamy.

1.1.3. European Elections and National Democracies

An intensification in the political debate on the EU and the euro area led to the production of analyses focusing primarily on the development of the perception of the European construction process held by grass-roots opinion in the various member states, including during general elections (for instance in Italy).

Specific work was devoted to the debate on the euro area aiming, among other things, the better to analyse instances of EU intervention on national democratic institutions.

And lastly, the run-up to the European elections in May 2014 prompted us to engage in work designed to clarify the political and party issues involved, a job which on we plan to continue working throughout the first half of 2014.

1.1.4. Citizen Dialogues

The NE-JDI continued to reach out to the man in the street, in accordance with its founder's explicit wishes and in connection with the "European Citizen Year" proclaimed by the European Commission.

These citizen dialogues were conducted in the context of partnerships with civil society, and in particular with the European Movement – France, with which we organised a cycle entitled "Droit d'inventaire – Droit d'inventer" ["Right of Inventory – Right to Invent"] to debate four issues of major importance for the EU (democracy, employment, the euro and the globalisation process) in eight medium-sized towns located in France's "eight Euro-constituencies".

These citizen dialogues also mobilised social players, in particular in the context of our cooperation agreement with the Macif. They also involved 2.0. citizens, for instance via the launch of our "citizens' web dialogue".

1.2. Strengthening the European Economic and Social Community

1.2.1. Towards a Fiscal, Economic and Banking Union

The NE-JDI continued to pursue its analysis of the current economic, social and political crisis and to submit proposals for addressing the crisis and for strengthening the Economic and Monetary Union.

In particular, the NE-JDI explored in considerable depth one of the proposals put forward by the Tommaso Padoa-Schioppa group, namely the establishment of a cyclical adjustment fund within the euro area. The NE-JDI endeavoured to analyse the best conditions for combining effectiveness and legitimacy in connection with the powers exercised at the national level. And lastly, the NE-JDI pursued its project on the creation of a budgetary capacity for the euro area, in particular through the adoption of a "super cohesion fund", as proposed by Jacques Delors.

1.2.3. "Social Europe", Current Situation and Future Prospects

The NE-JDI analysed the impact of the crisis, of austerity measures and of the reforms in the governance of the EMU on the European social model and on the division of competences between the national and Community levels.

The NE-JDI also conducted in-depth exploration of the arguments in favour of a social dimension for the EMU and the instruments and initiatives that would need to be adopted in order to achieve that end.

And lastly, the NE-JID looked at social competition and convergence within the EU, clarifying the importance of these two phenomena and identifying factors and projects for improving the EU's social dimension.

1.2.5. "The European Energy Community Is Now"

The NE-JDI continued to develop its political proposal for a European Energy Community, addressing in particular the challenge of European solidarity in the energy field. This project spawned a set of proposals regarding the implementation of the solidarity clause in the energy sphere, both inside (completion of the internal energy market and optimisation of energy resources in a sustainable manner) and outside the EU's borders (security of supply).



2. Our Operations

2.1.2. Notre Europe - Jacques Delors Institute at Conferences and Seminars

In 2013, the NE-JDI hosted or co-hosted 44 events (24 conferences, 18 seminars, 2 citizens' web dialogues) in 10 countries: Germany (2), Belgium (9), Cyprus (1), Spain (2), France (26), Lithuania (2), Portugal (1) and Romania (1).

This mobilisation showed a 10% increase over our activities in 2012 (40 events, as against 44 in 2013).

In 2013, our president, founding president and honorary president, our director and the members of our team were also regularly in demand to air their expert views at conferences and seminars hosted by other institutions and organisations.

These 116 appearances were spread out over 21 countries, with 43 in France, 64 in the EU (Austria, Belgium, France, Germany, Greece, Italy, Latvia, Luxembourg, The Netherlands, Poland, Portugal, Spain, Slovenia and the United Kingdom) and 9 outside the EU (Abu Dhabi, Ethiopia, Hong Kong, Monaco, Switzerland, the United State and Ukraine). This mobilisation showed a 65% increase over 2012 (70 appearances, as against 116 in 2013).

2.1.3. Notre Europe - Jacques Delors Institute in the Media

The NE-JDI regularly appears in the European and international media through the voices of its presidents, its director and its team. This allows us to add value to our work and to adopt a stance in the most important current debates.

In 2013 the NE-JDI presidents, director and team made over 220 appearances in the media of 19 countries in 2013 (as against 20 countries in 2012 and 15 countries in 2011), including 127 appearances in France, 58 appearances in other EU countries (Austria, Belgium, Cyprus, Denmark, Germany, Greece, Ireland, Italy, Portugal, Slovakia, Spain, UK) and 38 appearances in the international media (Brazil, China, Switzerland, Turkey, United States). The overall number of media appearances in 2013 showed an increase of over 10% compared to the figure for 2012 (193).

While the number of articles and interviews was either slightly lower or stationary, the number of references in 2013 (76) more than doubled compared to 2012 (37). This is a positive indicator because it proves that a media "reflex" certainly exists, inasmuch as the references took the shape of short interviews or quotes from addresses and remarks made at public conferences or taken from publications sent to the media.

The number of total or partial quotes from our publications (the publication of extracts from our projects and speeches either in the hardcopy press or on line) also showed an increase over 2013, thanks in particular to the partnerships that we forged with the *Huffington Post* (France) and with EurActiv.com (Brussels).

2.1.4. Notre Europe – Jacques Delors Institute on the Web

2.1.3.1. The NE-JDI's Website

The NE-JDI's website is the think tank's primary tool for both domestic and foreign communication. After a total overhaul in 2012, a new version was launched in September 2013 to allow the site to host videos and sound bites and to highlight an even larger number of publications. Thus the NE-JDI's website is now 100% "richmedia" and increasingly integrated with the overall group of social networks on which we operate.

The construction of this "richmedia" version of our website, combined with a particularly intense effort to develop our online profile, led to a 50 % increase in the number of unique visitors by comparison with 2012.

We continued to pursue our effort to expand our profile and our presence on the social networks in 2013.

Our Facebook account attracted another 1,000 fans, giving us a total of over 5,500 fans at the end 2013, which marks the NE-JDI out as one of the European think tanks with the largest number of followers on Facebook.

Our presence on Twitter, which began in 2011, has allowed us to mobilise almost 3,000 followers, a large majority of whom are experts specialising in European affairs.

In October 2013 our SoundCloud channel hosting our podcasts was set up to reach an even broader and more differentiated audience. The roughly one hundred podcasts that we produced in three months were listened to some 2,600 times.

2013 was also a year which saw a strong increase in our audiovisual output, with our YouTube channel hosting about 50 videos presenting our publications, our events and the citizens' web dialogues, as well as airing our presidents' and Board of Directors' views on European current affairs.

2.1.3.3. Citizens' Web Dialogues

In the context of our operations in the run-up to the European elections, the NE-JDI launched its Citizens' web dialogues in partnership with European media in mid-2013. This 100% digital concept is built around an interview with a European guest personality conducted on the basis of questions put to the personality by an online audience. People watching the interview on live streaming can also dialogue with the guest thanks to a chat line on the Facebook application.

2.1.3.4. Broadcasting in Conjunction with Stand Alone Media

In 2013 the NE-JDI piloted the production of two broadcasts produced by Stand Alone Media (Stand Alone Media is a network which creates, publishes and disseminates intellectual content in audiovisual format) by contributing the European know-how required to explore the chosen topics. The broadcasts serve several different purposes: exploring a topic of current importance in Europe through the educational standpoint of television broadcasts; adding value to the research and expertise of the NE-JDI's researchers; offering an educational explanation to the broader public; and in so doing, opening up the think tank's work to an audience which, while maybe not expert, is nevertheless interested in the issues currently on the European agenda. The broadcast in question is aimed primarily at a younger audience and is freely disseminated on the web, principally on the NE-JDI's site and its network but also on general or special interest media sites such as L'Étudiant.fr (agreement in principle). Two 10-12 minute broadcasts with approximately 1'30" teasers were produced on September 2013.

Broadcast 1: EU, democracy or despotism?

The EU is not just going through an economic crisis, it is also experiencing a fully-fledged crisis of confidence. It proved useful, in a broadcast, to return to the primary question associated with democracy, namely: is the EU still profoundly democratic, with all these institutions and with its complex decision-making process that the European man in the street has such difficulty in identifying?

Broadcast 2: Moving in Europe, an obstacle course?

The area in which people may now move freely was one of the European Union's first major achievements. Over the years the European Union has been gradually lifting all of the obstacles standing in the way of its citizens not only moving freely but also choosing to live in any of the Union's member states. Yet there are still numerous barriers hindering this freedom of movement, despite all of the directives and programmes designed to encourage it. The Erasmus programme has been facilitating exchanges between universities since 1987 and it has allowed thousands of students and teaching staff to study and train in European countries and, above all, to develop both a sentiment of understanding towards other European cultures and a European sentiment per se. In addition to fostering student mobility,

the European Union also facilitates professional mobility. But since the start of the recession, youth unemployment has reached a peak and more and more young people are choosing to settle and to work in other European Union member countries. Is it possible to be mobile in the European Union? Is the European Union truly an area without borders?

Working in conjunction with Grégory Guillotin, the NE-JDI commissioned a video entitled "Bengui in the European Parliament". The young comedian was sent by NE-JDI in Paris to meet with a number of MEPs at the European Parliament in Strasbourg. The video is aimed at a younger, non-expert audience with its offbeat tone, but at the same time it offers basic information on MEPs, on the European Parliament and on the European elections in May 2014. The video attracted over 100,000 hits in two months.

2.2. Our Team and Our Governing Bodies

2.2.1. Our Team

Nadège Chambon, our senior research fellow responsible for Agricultural, Rural Development and Citizenship, left the team in March 2013 to pursue her career elsewhere, while maintaining her post as associate research fellow in Agriculture and Rural Development. The NE-JDI team was bolstered in 2013 by the recruitment of a full-time officer for our Citizenship and Democracy project (Virginie Timmerman) in the run-up to the European elections.

Our Outreach and Support Department recruited a new officer for online dissemination (Nicolò Conti) and a management assistant, office manager and events manager(Isabelle Donnay).

Two of our researchers have been based outside France since the autumn of 2013: Sami Andoura is now in Brussels, where he combines his work as an NE-JDI senior research fellow with that of professor and chairholder of the ALCOA Chair of European Energy Policy at the College of Europe in Bruges; and Valentin Kreilinger is now in Berlin, where he is laying the groundwork for the opening of our Berlin office in the spring of 2014.

Since his mandate with the WTO came to an end in August 2013, our honorary president Pascal Lamy is now based in our Paris offices, where he supports and plays an active role in our activities.

And finally, in the course of 2013 the NE-JDI took in six interns (Marie Billotte, Nicolò Conti, Giorgio Garbasso, Emanuel Gyger, Chiara Rosselli and Virginie Timmerman), as well as availing itself of the collaboration of two temporary recruits (Kristina Maslauskaite and Claire Versini) to replace staffers on maternity leave.

At the end of 2013, the NE-JDI team comprised 13 staffers of six different nationalities (Belgian, French, German, Italian, Portuguese and Spanish) and it enjoyed the regular input of three advisers and four associate research fellows.

2.2.3. Our Board of Directors

In the course of its meeting on 23 March 2013, the board adopted a declaration entitled "EU and growth: Three pacts rather than one", which was published in the shape of a tribune by the *Huffington Post* and by the NE-JDI.

- 1. The first session, devoted to the theme of "Re-enchanting Europe", was introduced by Elisabeth Guigou, president of the French National Assembly's Foreign Affairs Committee and a former minister, and by Jonathan Faull, director general for the Internal market and services with the European Commission.
- 2. The second session, devoted to the theme of "Completing the Economic and Monetary Union", was introduced by Pedro Solbes, president of FRIDE and a former European commissioner, and by Daniela Schwarzer, director of the European Integration Department with SWP (German Institute for International and Security Affairs).

After the debates, a common declaration on the European elections in 2014 was adopted under the title "European elections: Full steam ahead!" for publication by a variety of different European newspapers: *Le Figaro* (FR), *La Razón* (ES), *Público* (PT), *La Repubblica* (IT), *Le Temps* (CH), *To Vima* (GR), *La Libre Belgique* (BE), *Handelsblatt* (DE) and EurActiv.com (EU).

2.3. Our Funding

The NE-JDI's overall budget in 2013 amounted to approximately 1.3 million euro, showing a slight drop by comparison with the previous year.

2.3.1. Our Resources and Partners

In 2013 the NE-JDI received support from four "major partners", who pledged multiannual donations greater than or equal to 100,000 euro.









Our activities also received recurring support from other partners:

The subsidies from the European Commission, the Compagnia di San Paolo and the Grand Duchy of Luxembourg in 2013 remained at the same level as in 2012.

Our partnership with the Macif was renewed for a three-year period (2013-2015) with a slight increase in the overall amount by comparison with the previous three-year period.

The annual subsidy allocated to us by the French Government, on the other hand, was cut by approximately 10% compared to 2012.

We were able to forge two new partnerships in 2013, one with the Gulbenkian Foundation for a three-year period (2013-2015) and one with GDF-Suez for 2013. This allowed us to stabilise the overall amount of our revenue deriving from partnerships at the same level as it stood in 2012.


A part of the NE-JDI's activities in 2013 were implemented on the basis of financial partnerships driven by specific projects, showing an increase over 2012:

- The "Think Global Act European IV" (2011-2013) project co-funded by the European Commission in its "Europe for Citizens" programme;
- The "Online Mobilisation" (2012-2013) project co-funded by the French Ministry for Foreign and European Affairs in a management partnership with the Paris office of the European Commission;
- A report on the social dimension of the EMU (2012-2013) co-funded by the Austrian Chancellery;
- The "Rural Areas" project co-funded by the French Ministry of Agriculture and the Regional Council of Rhône-Alpes (2013);
- The "Horizon EU" project co-funded by the European Commission in its "Europe for Citizens" programme, by the Charles Léopold Mayer Foundation and by the Hippocrène Foundation (2013-2014);
- The "Droit d'inventaire Droit d'inventer" ["Right of Inventory Right to Invent"] project (in partnership with the European Movement France) (2013-2014) co-funded by the French Ministry of Foreign and European Affairs in a management partnership with the Paris office of the European Commission;
- The "EUSTORY" project co-funded by the European Commission office in France (2013-2014).

All in all, contributions from our major partners and ordinary partners accounted for 85% of our revenue in 2013, while contributions driven by specific projects accounted for 14% and subscriptions and fees for approximately 1%.

The NE-JDI also benefited from support in kind, in particular in the shape of an offer of premises to host our events, from the Paris offices of the European Commission and the European Parliament, of the European Economic and Social Committee, of the Committee of Regions, of the French National Assembly and of the General Council of the Drôme.

Breakdown of the resources of Notre Europe - Jacques Delors Institute in 2013




2.3.2. Our Expenditure

In 2013, expenditure for Notre Europe – Jacques Delors Institute was broken down, as in previous years, into three relatively equal parts:

- Expenditure linked to our research activities represents approximately 36% of the total amount: this mainly corresponds to the remuneration of our research fellows, as well as expenses related to payment of external authors and the organisation of seminars;
- Expenditure linked to information dissemination activities represents 35% of the total amount: this corresponds to the remuneration of our team members in charge of activities that include dissemination, publishing, communication, and the organisation of public events, as well as translation and printing expenses;
- Expenditure linked to support activities and our day-to-day running represents 29% of the total amount: this mainly corresponds to the remuneration of our team members in charge of support functions (management, administration, etc.) as well as costs related to running our premises (mainly rent and depreciation).
