



Eurosfat 2014: Quo Vadis Europe?

Eurosfat is the annual stakeholders' forum on European affairs organized in Romania. The purpose of the event is to bring together politicians, civil society, the private and public sector and citizens in order to discuss and to shape the positions and the expectations they have towards the European Union.

The second edition of Eurosfat will take place on Monday, 7 April 2014, at the Palace of the Parliament in Bucharest and will be entitled "Quo Vadis Europe?". On the eve of the European elections, those active in European policies are invited to take stock of the past years and to set forth recommendations for new MEPs and the new European Commission. Candidates for the European Parliament elections will participate in special debates to answer questions of the civil society on the form and content of their European commitment. Furthermore, a special high level debate will be organized with leaders of the main European political parties, including designated candidates for the Presidency of the next European Commission.

The first edition of Eurosfat was organized by the Europuls Association together with over twenty partner organisations, on the 15th of March 2013, at the Palace of the Parliament in Bucharest. The event was highly successful and was attended by over 600 participants. Among its guests we recall the presence of the European Commissioner, Dacian Cioloş, of distinguished Members of the European Parliament: Norica Nicolai, Cristian Preda, Adina Vălean, Ioan Enciu, Amelia Andersdotter, as well as of Members of the Romanian Parliament, European and national officials, NGOs, think-tank representatives and citizens.

The forum is structured in two main plenary sessions and six thematic workshops. The opening plenary will concentrate on European elections and possible ways of improving the electoral process, while the closing plenary session will be a live broadcast high level meeting in which the leaders of the main European political families will present their views on the future of the European Union ahead of the European elections and the subsequent designation of the new President of the European Commission.

The workshops will be organised as candidate debates and expert debates. The candidate debates will bring into attention the political programmes and the vision of those participating in the campaign for the European elections. The expert debates will highlight the role of civil society representatives, public policy experts and citizens vis-à-vis improving the positions and status of Romania as a EU member.
